

AUDIT COMMITTEE CHARTER (updated as of of ugust 2022)

I. Purpose and Authority

The Board of Directors (the Board) News Corporation (the Company) has established an Audit Committee (the Audit Committee or the Committee) with the authority, responsibly and specific duties as described below.

The Audit Committee shall assist the Board in its oversight of (i) the Company's accounting and nancial reporting processes and systems of internal controling the audits of the Company's financial statements and the integrity of financial statements (ii) the qualifications, independence and performance of the Company's independent registered public accounting firm and the performance of the Company's corporate auditors and corporate audit fur(it) othe Company's compliance with legal and regulatory requirements olving financial, accounting and internal control matters, (iv) investigations into complaints concerning financial matters, and (v) risks that have a significant impact on thempanys financial statements had audit Committeeshall also provide an avenue of communication among management, the independent registered public accounting firm, the corporate auditors and the Board of Directors.

In fulfilling its responsibilities, the **Condit**nittee shall have full access to all books, records, facilities and personnel of the Company, and shall be authorized (without seeking approval of the Board) to retCommittee s duties. In addittiorequest addit Committee officer or employee of the Company or the Company s outside counsel or independent registered public accounting firm to meetanyitmembers of, or assors to, the Audit Committee. The Audit Committee may delegate its authority to subcommittees or the Chairman of the Audit Committee when it deems appropriate and in the best interests of the Company.

II. Composition and Meetings

The Audit Committee shall be comprised of three or more directors as determined by the Boardupon the recommendation of Mominating and Corporate Governance Committee, each of whom shall be independent directors in accordance with the Nasdaq Stock Market IIC (Nasdaq) listing standards and who meet the additional independence requirements Masdaq for audit committee membership, as determined by the Board.

Each member of the Committee must be financially literate, as determined by the Board. At least αe member of the Audit Committee must be an audit committee financial expert, as determined by the Board in accordance with Securities and Exchange Commission (SEC) ruleNo member of the Audit Committee may have participated in the preparation of the Company or any current subsidiary of the Company at any time during the past three years.

The members of the Committee shall be elected may be removed by the Board The Boardshall designate a Chairman of the Momintee sponther recommendation of the Nominating and Corporate Governance Committee.

No Committee member should simultaneously serve on the Audit Committee of more than two other public compa**with**out the prior approval of the Board.

The Committee shall meet east quarterly or more frequently as circumstances dictate. The Chairman of the Audit Committee, in consultation with the other Committee members, shall determine the frequency and length of the Committee meetings and shall set meeting agendas consistent whis Charter. A majority of the members of the Committee shall constitute a quorum part of its job to foster open communication, the Committee should memoriodicall with management, the healt the corporate audit department and the independent stered public accounting firm in separate executive sessions to discuss any matters that the Committee or each of these groups believe should be discussed privately. The Committee shall also meet periodically in executive session where no members of management or the auditors shall be present. In addition, the Committee, or at least its Chairman, should hold discussions with the independent registered public accounting firm and management as needed regarding the Company s financial statemements internal control over financial reporting
